Camp Fully Involved is an intense, hands-on fire service based camp for young women between the ages of 15 and 20, who are interested in a career in the fire service. Class size will be limited to 16-25 cadets in order to provide the safest, most interactive hands-on program. Applicants not accepted into the 2010 program will be considered first for the 2011 program. Only COMPLETE applications will be reviewed and accepted. A complete package will include the cadets application, 2 letters of recommendation and a 500 word essay. Selection for the program is random, and no preference is given to applicants who may have fire service experience or affiliation.

Application Package Checklist:

- Completed Application (page 1 only), with appropriate Signatures (postmarked by May 1, 2010)
- 2 Letters of recommendation from adults not related to you (i.e. teacher, coach)
- 500 Word essay titled "Why I am interested in a career in the fire service"

All applications, essay and letters of recommendation must be postmarked May 1st, 2010. Applications received after that will not be processed. Please do NOT send payment for camp with application.

Once selected to Camp Fully Involved, you will need to submit the following items postmarked by June 30th, 2010:

- Summer Camp fee of \$300.00**
Checks made payable to : Fire Instructors and Officers Association of N.H.
- Signed Authorization for physical**
- Signed Participant Release of Liability Form**

** The Summer Camp fee includes 4 T-shirts for each cadet, all meals, snacks and lodging in the NH Fire Academy dormitory.
